These taxes may apply on new or used goods depending on, among other things, the type of product and if the goods are used in local business. For example, diapers or laundry powder will be taxed.</li> <li>▪ Customs officials make the final decision on the application of duties and taxes. This decision will also depend on the client's ability to provide the original purchase invoices.</li> <li>▪ Please contact your local agent for more details on this matter.</li> <li>▪ Please note that customs do not accept export sales slips, sales receipts, and purchase orders.</li> <li>▪ If your move contains both used and new personal effects, please submit one inventory for the used items, and one inventory for the new items.</li> </ul>

The amount of tax charged will be provided upon presentation of a copy of the registration card and the Argus value.</li> <li>▪ Used vehicles intended for the transport of persons and goods must be less than eight years old for: <ul style="list-style-type: none"> <li>▪ Tourist vehicles</li> <li>▪ Taxis</li> <li>▪ Bus of 26-36 seats</li> <li>▪ Bus up to 36 seats</li> <li>▪ Trucks of 3.5T up to over 5T</li> </ul> </li> <li>▪ These provisions don't apply to the following vehicles: <ul style="list-style-type: none"> <li>▪ Foreign diplomats resident in the Republic of Djibouti</li> <li>▪ Djiboutian diplomats and Djiboutian international civil servants in the context of their move at the end of their mission abroad</li> <li>▪ All Djiboutians residing abroad for professional reasons returning to Djibouti.</li> </ul> </li> </ul>	<ul style="list-style-type: none"> <li>▪ The client must provide their local mover with the engine and chassis numbers of any vehicle imported into Djibouti. The chassis number can be found on the vehicle registration certificate.</li> <li>▪ The technical inspection authorisation (used vehicles) must be issued by a structure approved by the country of origin of the vehicle.</li> <li>▪ Right-hand-drive vehicles are prohibited.</li> </ul>

<b>Prohibited items</b>		<ul style="list-style-type: none"> <li>▪ Weapons</li> <li>▪ Drugs and narcotics</li> <li>▪ Counterfeits</li> <li>▪ Drones</li> <li>▪ Cigarettes</li> <li>▪ Alcohol (excluding appropriate declarations)</li> <li>▪ Ivory</li> <li>▪ Ostrich eggs</li> <li>▪ Turtle shell</li> <li>▪ Coral</li> <li>▪ Shells</li> <li>▪ Stuffed animals</li> <li>▪ Animal skins</li> </ul> <p>Or any other species taken up by the Washington Convention.</p>	<ul style="list-style-type: none"> <li>▪ Airsoft and paintball: these items have recently been considered as dangerous and are now prohibited.</li> <li>▪ Household products (washing powder, diapers, soap, etc.) are not considered as used HHGs. Their import can lead to customs hold and extra charges.</li> <li>▪ Alcohol import is not prohibited. It is, however, discouraged through prohibitive taxes: 33%-147% (depending on alcohol strength) + 10% VAT.</li> <li>▪ For wine and all other alcohol, you must submit a detailed and separate inventory from personal effects.</li> </ul>
